This allows you to create a Smart security system simply and quickly. Linea 3000 entrance panel with black finish zamak front panel, wide-angle color camera and proximity reader with a kit of colored badges and two clear discs for door lock activation / release. Can be wall-mounted or flush-mounted with the specific accessories: (350020) flush-mounted box and (343063) flush-mounted accessory - to be purchased separately. It can be equipped of rainproof roof (343053) – to be purchased separately. The entrance panel has an IP54 degree of protection - IK10 degree of robustness.
